**RESULTS OF THE FEBRUARY 2025 ARIZONA UNIFORM BAR EXAMINATION**

The February 2025 Arizona Uniform Bar Examination (UBE) was administered on February 25 and 26, 2025. There were 253 applicants, of whom **129** met the score requirement for admission in Arizona. The overall pass rate was **51%**.

The following individuals received the highest scores on the examination:

First Place: Fabi Mansoor Behnam; Encino, California. A 2022 graduate of Pepperdine University School of Law.

Second Place: In compliance with Ariz. R. Sup. Ct. 37(c)(2), applicants who applied pursuant to Rule 34(b)(2) and who have not satisfied the evidence of graduation requirement are not listed. Upon submission, a revised list will be posted.

Third Place: In compliance with Ariz. R. Sup. Ct. 37(c)(2), applicants who applied pursuant to Rule 34(b)(2) and who have not satisfied the evidence of graduation requirement are not listed. Upon submission, a revised list will be posted.

Applicants who have met all examination and character and fitness requirements have been recommended for admission to the practice of law in Arizona. Applicants still completing requirements will be recommended for admission at a later date.
